ITEM 2: DISCUSS AND/OR APPROVE CHANGE ORDER #1 FOR THE DOWNTOWN IMPROVEMTS PROJECT IN THE AMOUNT OF (\$863.45):

Tibbs states originally, we received two grants to fund this project the DEO grant and the FDEP grant. Change order #1 is a decrease of \$863.45 for revising the parking at the end of Ave J and Riverside Dr. change order #2 comes about for the need to go back and do some de-mucking.

Eighner states we are here today to approve the change orders to keep moving and then we can always come back and discuss the issues we have had.

Browning states I know 3 people in here that were saying when we got the bid and it stated "no de-mucking" said asked are you sure.

Eighner states they have cost us three hundred thousand dollars and liability.

Browning states at another meeting I think we need to discuss that we are not taking that three hundred thousand dollar hit. I just don't think its fair.
