ITEM 2: DISCUSS AND/ OR APPROVE THE LETTER OF INTENT TO PURCHASE A SANITATION TRUCK FOR THE FY 24-25 BUDGET:

Tibbs sates our current garbage truck has been down a couple times we are not exactly sure what is wrong with it, but we cannot depend on it. We do have it in the new budget to purchase a new truck, but we cannot issue a PO until October 1st. Simmons has been out looking for one.

Simmons states I looked at a 31-yard truck in Clewiston. It’s a year and a half old truck. It has a good body and arms on it, but it has a Pack R motor in it which is an off brand of a Cummins. It has a Peter Build chase. They said it has been in the shop 4 times just in the year and a half they have had it so. I would stay away from that one. So, there are some more trucks in Naples they are Crain Car and have the Cummins motor. They are a lot better set up and we plan on having a truck for at least 10-15 years.

Tibbs state this is a piggyback off of the Sheriffs Association contract. So, it’s one we don’t have to go out for bids on. The total price is \$439,924.00 we budgeted \$400,500.00. The price dose goes up in October 1st, but they are willing to hold the price with a letter of intent.

Decker states is there any warranty on the engine.

Simmons states there is a 5-year warranty or 100,000 miles.

Tibbs states this will be paid for through CaPFA.
