INVITATION TO BID

Sealed BIDS will be received by **CITY COUNTY PUBLIC WORKS AUTHORITY** (hereinafter referred to as Owner), at **299 Riverside Drive, MOORE HAVEN, FLORIDA 33471** until **2:00 PM** on **July 18, 2025** at which time they will be publicly opened by the City Clerk or designee and read aloud. Any BIDS received after the time specified will not be accepted.

The BIDS shall be based on providing all materials, equipment and labor for the **CCPWA BALL PARK LIFT STATION REHABILITATION PROJECT**.

The project consists of the rehabilitation of the existing ballpark lift station, including new duplex submersible pumps, wet well and valve vault pipes and fittings, and new electrical controls including level controls. The Contractor shall be responsible for providing all materials, equipment and labor as necessary to complete the project per the plans and specifications.

BIDDERS shall confine their BIDS to the project in its entirety. Partial BIDS will not be considered. Each BIDDER shall submit with this BID evidence that he is licensed to perform the work and services or qualified by examination to be so licensed.

Each BID shall be accompanied by a certified check or by an acceptable BID BOND in an amount equal to at least five (5) percent of the amount of the BID payable to **Glades County**, as a guarantee that if the BID is accepted the BIDDER will execute the CONTRACT and file acceptable PERFORMANCE AND PAYMENT SURETY BONDS equal to one hundred percent (100%) of the contract price within ten (10) days after written notice of the AWARD OF CONTRACT. No bidder may withdraw his BID for a period of ninety (90) days after date set for opening of the BIDS.

CITY COUNTY PUBLIC WORKS AUTHORITY reserves the right to: waive informalities in any BID, delete any portion of the project; extend the project within the limits of the work involved. The Owner has the right to accept or reject any or all bids.
