**Citizen Brooks** states I live at 259 Ave O and I'm the owner of the new Sticz Cigar Lounge. I had a conversation with Mrs. Palmer, and she told me the City is confused on what we do there. So, she suggested I come and have a conversation with Miller. I was under the impression we were going to sit down and discuss what is happening and go over my licenses and permitting. I did not get the opportunity. Upon entering the lobby, I was greeted rudely by Miller, and I tried to show her my documents. But if you guys have any questions, I will be glad to answer them.

**ITEM 8: MAYOR AND COUNCIL TO GIVE REPORTS:**

**Croskey** states I know we always spoke about wanting business to come to Moore Haven, so let's try and keep them here.

**Beck** states I'm for all businesses as long as it's all done correctly. I believe our lawyer is working on stuff and making sure things are good and once he gets back to us, we will reach out to you to make you aware. Another thing I have is something an employee has brought to my attention. I'm not sure if it would be a good idea or not but with the dumpsters is there anything stating we have to provide dumpster services.

**Tibbs** states I'm sure it's in the ordinance that we have dumpsters. It's not a requirement.

**Beck** states paying \$275k for a dumpster truck plus replacing the dumpsters when it's needed. I'm just thinking in the long run, we are probably barely breaking even on dumping fees. I think we might need to look into this and run some numbers. Another thing is automatic meters, when I worked at Glades Electric, they had meters you rode by, and they synced to a clicker. Then they upgraded to meters that synced to the computer in the office. But when they upgraded, they sold those meters to a company, and nothing was wrong with them. I'm wondering if there is a larger City that maybe going away from those meters that we could piggyback on. That is one of my top priorities even if we got one or the other electric or water.

**Decker** states I just wanted to mention to Simmons and Tibbs about getting the docks out front coated and sealed.

**Simmons** states we will look at it.

**Browning** states there are still some Code Enforcement issues around town that still need to be taken care of.

**Croskey** states I'm just having some concerns about us City Council & Employees on how we present ourselves. I'm bothered from hearing what Mr. Brooks had to say, and if that is the case it's wrong.

**Browning** states I think what needs to happen with this conversation if you don't mind, is let Tibbs and Miller discuss it. I don't think it is something that needs to be done in open form unless we can't get it resolved and I recommend any conversations that do take place, Mr. Ramunni should be included in.
