**Simmons** states while we are on the subject of parks. I have had to send PJ to the park right there by City Hall a few times here recently to repair some stuff due to rust and bolts coming out. We may want to start thinking about replacing some of that equipment in the future.

**Wills** states we did send Ian over there and she was actually there when he got there. Ian did explain that it did go through the meter.

**Council** agrees to allow Wills to set up a payment arrangement.

**MOTION:** By Croskey to allow Wills to set up a payment arrangement for Citizen Aguilar at 701 5<sup>th</sup> Street, seconded by Smith. Motion Carried.

**Citizen Scott** states I am the Pastor at 628 Ave A. I'm here to ask the Council to allow New Life Ministry to operate New Life Christ Academy at our Church. We want to open a private and faith-based School on the Church grounds, to serve the children of Moore Haven.

**Wills** states as long as it will remain a church from my understanding the zoning won't be an issue. You do have to get an occupational license for the school and have all the States requirements.

**Browning** state last week I met with Carlisle cause as we all know Brown is getting ready to retire. Carlisle has some ideas; one is going to U.S Water, which is a contractor. At this time.
